Cynthia McCarty, Chairperson, called the meeting to order at 4:15 pm.

## 1. Approval of Minutes

## 5. New Business

Denise presented the proposed budget for the NCTRC. As of this evening the numbers have not yet been finalized, so we are using last year's numbers (\$190,102)

- Motion to approve the 2025 -2026 FS10 in the amount of \$190,102 - T. Figoni and second B. Fregeau: Motion carried, unanimous.

In the case of a cut, we will also vote on a contingency budget in the amount of \$126,723. This will hold many challenges as the amount doesn't even cover the director's salary or benefits. We will need to change many things in the center if this is the amount we get. If that happens we will meet again to brainstorm.

- Motion to approve the 2025 - 2026 Contingency budget in the amount of \$126,723 - V. Washburn and second M. Niquette: Motion carried, unanimous with J. Stapely abstaining

The professional learning opportunity application has been posted online. If we get applicants we will meet to discuss on July 21 at 11am. Anyone is welcome to come. Denise will send out a reminder for policy board members to share.

Bailey Fregeau requested to attend an SLP conference in July. The conference is in Washington DC. She is requesting conference registration and travel (but not lodging). Bailey will continue to offer classes at the NCTRC with the information gleaned from this event.

- Motion to approve Bailey Fregeau attending the SLP conference in July (pending funding) not to exceed the amount of \$1500 C. McCarty 2nd C. Butts: Motion carried, unanimous B. Freageau abstaining

We came up with the idea at the self-study to buy laptop computers to replace the old desktops in the lab. This will enable people to move around, connect to the wireless, etc. We will come up with systems to make it work (sign outs, cart, docking station, etc).

-Motion to approve (pending budget approval) purchasing 12 laptops for the lab B. Fregeau 2nd B. LeClair: motion carried, unanimous

At the April Self-study we also discussed a flyer to advertise the NCTRC. Heather will make a QR code and the flyer can be printed and put in faculty rooms or shared online.

Results from the needs assessment (so far) were shared with the group. We will use the suggestions to plan what professional learning will be done during the year and beyond.
